NEWSRADIO 102.9 KARN FM "OCTOBER 2024 CREED/MAMMOTH WVH TICKETS TEXTING CONTEST" CONTEST OFFICIAL RULES

The Station will conduct the **NewsRadio 102.9 KARN FM "OCTOBER 2024 CREED/MAMMOTH WVH TICKETS TEXTING CONTEST"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. - 2. Contest Period. The Contest entry period will begin at 6am on October 21, 2024 and will run weekdays from 6am until 9am through October 25, 2024 (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.
- 3. How to Enter and Win. Listen to the Station during the Contest Period. At or around 6a-9a each weekday (each, a "Selection Day"), when the Station plays the cue to call, sounder/song, listeners must text the Station at 501-403-5276. A random text, as determined by the Station in its sole discretion, will be the winner for that Selection Day after providing the Station with the winning listener's name and phone number, subject to verification and compliance with these Contest Rules. All entries may be played on the air. *Time Delay Between Over-the-Air Analog Signal and Internet Broadcast:* Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished. Station's decisions as to the administration and operation of the Contest.
